


Figure 2-3	Percentages of registered candidates and qualified examinees of Junior

Figure 1-2 Percentages of female registered candidates of Civil Service Examinations by type (2011-2015)





Figure 1-3 Examination attendance rate of Civil Service Examinations by type (2015)

Figure 1-4 Examination attendance rate of Civil Service Examinations by type (2011-2015)





Figure 1-5 Percentages of qualified examinees of Civil Service Examinations by type (2015)



Figure 1-6 Qualification rate of Civil Service Examinations by type (2011-2015)



Figure 1-8 Percentages of registered candidates of technicians in Civil Service Examinations by type (2011-2015)




Figure 1-9 Percentages of qualified examinees of administrative personnel in Civil Service Examinations by type (2011-2015)




Figure 1-10 Percentages of qualified examinees of technicians in Civil Service Examinations by type (2011-2015)




Figure 1-11 Qualification rate of administrative personnel in Civil Service Examinations by type (2011-2015)





Figure 1-12 Qualification rate of technicians in Civil Service Examinations by type (2011-2015)

Figure 1-14 Percentages of qualified examinees of Special Civil Service Examinations by examination name (2011-2015)






Figure 1-15 Gender Disparity in the percentages of qualified examinees of Special Civil Service Examinations in select examination names

Figure 2-2 Percentages of registered candidates and qualified examinees of Senior Professional and Technical Examinations by category (2015)




Figure 2-3 Percentages of registered candidates and qualified examinees of Junior Professional and Technical Examinations (2015)







Figure 2-4 Percentages of registered candidates and qualified examinees of Junior Professional and Technical Examinations by category (2015)

Figure 3-2 Percentages of female civil servants by agency (end of 2011-2015)




Figure 3-3 Percentages of female civil servants by county(city) (end of 2015)




Figure 3-4 Percentages of level of education of civil servants (end of 2015)




Figure 3-5 Percentages of civil servants by rank (end of 2015)




Figure 3-6 Percentages of female civil servants by rank (end of 2011-2015)




Figure 3-7 Percentages of civil servants by age (end of 2015)




Figure 3-8 Percentages of civil servants as supervisors (end of 2015)





Figure 3-9 Civil servants applying for parental leave without pay and restoration (2011-2015)







Figure 4-1 Percentages of screening and review results of civil servants performance evaluation by gender (2014)






Figure 4-3 Percentages of screening and review results of civil servants performance evaluation by rank (2014)

Figure 4-5 Number of civil servants receiving Distinguished Achievement Award by agency (2015)




Figure 4-6 Number of civil servants receiving Distinguished Achievement Award by rank (2015)





Training for Elementary, Junior and Senior Civil Service Exam qualifiers








Figure 5-3 The average of on-the-job training hours for civil servants by rank (2011-2015)




Figure 5-6 Percentages of mid-long term developing training for Senior civil servants (2011-2015)



Figure 6-1 Status of civil servants retirement review by type (2015)





Figure 6-2 Percentages of civil servants retirement review by rank (2015)





Figure 6-3 Average age of civil servants retirement review by rank (2015)





Figure 6-4 Number of civil servants voluntary retirement review by age (2015)






Figure 6-6 Percentages of civil servants survivor relief review by age (2015)



Figure 7-1 Status of employees of Examination Yuan and subordinate agencies by gender (end of 2015)





Figure 7-2 Percentages of personnel of Examination Yuan and subordinate agencies by agency (end of 2015)




