


Figure 5-1	Percentages of applicating right protection cases in civil servants by gende (2019-2023)

Figure 1-4 Examination attendance rate of Civil Service Examinations by type (2019-2023)





Figure 1-5 Percentages of qualified examinees of Civil Service Examinations by type (2023)

Figure 1-6 Qualification rate of Civil Service Examinations by type (2019-2023)



Figure 1-10 Percentages of qualified examinees of technicians in Civil Service Examinations by type (2019-2023)






Figure 1-11 Qualification rate of administrative personnel in Civil Service Examinations by type (2019-2023)

Figure 1-13 Percentages of qualified examinees of Special Civil Service Examinations by examination name (2019-2023)





Figure 1-14 Gender Disparity in the percentages of qualified examinees of Special Civil Service Examinations in select examination names (2019-2023)



Figure 2-2 Percentages of registered candidates and qualified examinees of Senior Professional and Technical Examinations by category (2023)






Figure 2-3 Percentages of registered candidates and qualified examinees of Junior Professional and Technical Examinations (2023)






Figure 2-4 Percentages of registered candidates and qualified examinees of Junior Professional and Technical Examinations by category (2023)






Figure 3-4 Percentages of level of education of civil servants (end of 2023)





Figure 3-5 Percentages of civil servants by rank (end of 2023)

Figure 3-6 Percentages of female civil servants by rank (end of 2019-2023)





Figure 3-7 Percentages of civil servants by age (end of 2023)

Figure 3-8 Percentages of civil servants as supervisors (end of 2023)





Figure 3-9 Percentages of indigenous civil servants by personnel category (end of 2023)

Figure 3-10 Percentages of disabled civil servants by personnel category (end of 2023)





Figure 3-11 Civil servants applying for parental leave without pay and restoration (2019-2023)



Figure 3-12 Percentages of civil servants applying for parental leave without pay and restoration by the period of leave (2023)




Figure 4-1 Percentages of screening and review results of civil servants performance evaluation by gender (2022)




Figure 4-3 Percentages of screening and review results of civil servants performance evaluation by rank (2022)


Figure 4-4 Percentages of performance evaluation results for civil servants restoring from parental leave without pay (2022)

Figure 4-6 Number of civil servants receiving Distinguished Achievement Award by rank (2023)






Figure 4-7 Percentages of civil servants receiving Model Civil Servants Award by agency (2023)

Figure 5-1 Percentages of applicating right protection cases in civil servants by gender (2019-2023)







Figure 5-2 Percentages of right protection case results in civil servants by gender (2019-2023)

Figure 5-3 Percentages of training for Civil Service Exam and Special Civil Service Exam qualifiers (2019-2023)



Figure 5-5 Qualification rate of training for Civil Service Exam and Special Civil Service Exam qualifiers (2019-2023)



Figure 5-8 Percentages of promotion training by type (2023)




Figure 5-9 Percentages of promotion training by type (2019-2023) Elementary to Junior Rank Junior to Senior Rank promotion training promotion training Male% Female% year 20... 55.1 44.9 59.9 40.1 54.0 46.0 20... 39.3 60.7 20... 55.4 44.6 40.5 59.5 20... 55.3 44.7 40.9 59.1 42.0 58.0 54.5 45.5 20... Police Major to Superintendent Rank Police Sergeant to Major Rank Promotion training Promotion training year Male% Female% 2019 87.0 13.0 91.4 8.6 2020 86.1 13.9 92.3 7.7 2021 92.1 7.9 2022 93.1 6.9 89.4 10.6

Figure 5-10 Qualification rate of Junior to Senior rank promotion training and Elementary to Junior rank promotion training (2019-2023)






Figure 5-11 Qualification rate of Junior to Senior rank promotion training of Police Officers and Elementary to Junior rank promotion training of Police Officers (2019-2023)

Figure 5-13 Percentages of developing training for Senior civil servants by type (2023)






Figure 5-14 Percentages of counsellor of training for Civil Service Exam and Special Civil Service Exam qualifiers (2019-2023)









Figure 6-1 Overview of civil servants retirement review by type (2023)





Figure 6-2 Percentages of civil servants retirement review by rank (2023)





Figure 6-3 Average age of civil servants retirement review by rank (2023)





Figure 6-4 Number of civil servants voluntary retirement review by age (2023)






Figure 6-6 Percentages of civil servants survivor relief review by age (2023)


Figure 7-1 Overview of employees of Examination Yuan and subordinate agencies by gender (end of 2023)



Figure 7-2 Percentages of personnel of Examination Yuan and subordinate agencies by agency (end of 2023)




