3.Employment refers to those who are at least 15 years old and meet one of the following conditions:

- (1) Engaged in paid work, or work with unpaid family members who work more than 15 hours a week;
- (2) Not working workers who have been paid;
- (3) Those who have been hired and paid but have not started for some reason.
